#### **SURVEY INTRODUCTION AND METHODOLOGY**

#### **INTRODUCTION**

Our 2022 survey of Southern California law firms contains information from 90 firms with 128 office locations. The geographical dispersion of the participating offices is as follows: 28 offices in Downtown LA, 43 offices in Los Angeles Westside, 10 offices in San Fernando and San Gabriel Valleys, 26 offices in Orange County, 15 offices in San Diego, and 6 offices in other Southern California locations.

Of the participating firms, 22 of them have 1-20 attorneys firm-wide, 20 have 21-50 attorneys firm-wide, 13 have 51-150 attorneys firm-wide, 11 have 151-500 attorneys firm-wide, and 24 firms have 501 or more attorneys.

Compensation and/or billing data was collected and reported for 70 total position categories.

#### **SURVEY CONFIDENTIALITY**

Numerous security procedures and controls are in place to safeguard and protect the confidentiality of the participating firms and the reported data.

Your completed survey data was sent directly to Armanino for tabulation and summarization. Only one individual within our firm has access to this information. All individual firm data is strictly confidential and will not be disclosed or distributed to any party by Armanino.

#### SURVEY METHODOLOGY AND ANALYSIS

Firm sizes are determined based on the TOTAL number of attorneys firm-wide (as opposed to attorneys within the reported office location.)

The geographical locations reported in the survey are as follows:

**Downtown LA:** includes downtown and mid-Wilshire areas

Westside: includes Beverly Hills, Century City, Westwood, Brentwood, Santa Monica, El Segundo, Marina del Rey, and related areas

San Fernando/San Gabriel Valley: includes Sherman Oaks, Westlake Village, Woodland Hills, Encino, Pasadena, Glendale, Burbank, Van Nuys, Universal City, and related areas

Orange County: includes areas between Seal Beach and San Diego

San Diego: includes areas from Carlsbad to all San Diego area zip codes

Other: includes other areas throughout Greater Los Angeles And Southern California not specifically identified above

Please note that within the compensation and billing sections, the total number of firms by size will equal the All Firms number. In the Location section, the total firms in all locations may not equal the All Firms number because each participating firm may have multiple locations. Similarly, the total firms by Practice Area, Class Year, etc. may not equal the All Firms number because each firm employs individuals within multiple categories.

#### SECTIONS II, III, and IV – GENERAL QUESTIONS, EMPLOYEE BENEFITS, & MARKET CONDITIONS

These sections report the responses on the general questions regarding firm operations and data, employee benefits, and industry conditions. Some data in these sections is reported by the number of firms responding, while other data is reported by percentage of total responses. Since all participants did not respond to each question, the analyses are reported only for those firms that responded.

#### SECTION V – ATTORNEY COMPENSATION, BILLING RATES, AND BILLABLE HOURS

This section reports the responses on base salary, bonuses, billing rates, and billable hours for full-time Partners, Associates, and Of-Counsel. The salaries reported were those in effect on July 1, 2022, and bonuses reported were the bonuses paid in the previous prior year. The categories of the analyses in this section (also applicable to all other sections), are as follows:

Average – The sum of all numbers within a category divided by the number of reported

10<sup>th</sup> Percentile – The amount that has 10% of the reported values below it

25<sup>th</sup> Percentile – The amount that has 25% of the reported values below it

Median – The amount where there is an equal number of reported values both above and below

75<sup>th</sup> Percentile – The amount that has 75% of the reported values below it

90th Percentile – The amount that has 90% of the reported values below it

For certain positions, a small number of incumbents and corresponding data were reported for various categories. In order to maintain the confidentiality of individual data, certain statistical information was omitted based upon the number of firms and incumbents reported. The omitted information is noted by an asterisk (\*) in the statistical data.








### **Total Compensation**



## **Billing Rates**




#### **Billable Hours**




### **Total Compensation**






## **Paralegals**

















# Firm Count by Size (# of Attorneys)




# Firm Count by Location (# of Offices)








